Qualification and Experience – MBBS degree recognized by Medical Council of India (MCI) with minimum 03 years working experience (after mandatory internship) in a Govt. hospitals or large corporate or Public Sector Undertaking Hospital. Preference will be given to candidates having Post-Graduate Degrees in Clinical Subject.

Age: Upper age limit 32 years as on the interview date.

Appointment will be initially on a temporary basis for a period of 01 year and likely to be extended for a further period based on satisfactory performance and necessity of the Institute.
