Hence the above minimum qualification must be applicable for Dr. Vinay Wagh while Dr. Wagh shortlisting for Assistant Professor in the Department of Mathematics, IIT Guwahati in the year 2008. Please note that this selection happened during the headship of Prof. Rafikul Alam.		
Information Sought (जानकारी मांगी):	It is revealed by an RTI reply that Dr. Vinay Wagh does not possess the first-class degree in his master and passed his Master degree with the second division that Dr. Vinay Wagh did not possess first-class degree both in his master as well as his both bachelor degree. I am unable to understand why this minimum qualification (which is in the public domain on www.iitg.ac.in) has been relaxed while appointing Dr. Vinay Wagh as Assistant Professor in the Department of Mathematics, IIT Guwahati in the year 2008 by the then Head of Department of Mathematics Prof. Rafikul Alam. Please refer to the judgment of Honorable Madras High Court about IIT Madras faculty selection, Dr. B. Vasantha vs Dr. Pawan Goenka on 17 February 2017.
