threatening letters were received by the members of the institute by Dr. B K Rai. In this regard, please provide the following information under RTI Act 2005:

1) Please provide me the certified copies of the scanned copies of all such threatening letters mentioned in the above mentioned RTI reply.

2) Please provide me certified copies of all the communication made by employees to the director/deputy director/board of governors who received threatening letters.

3) Please let me know whether Dr. B K Rai was an employee of IIT Guwahati when threatening letters were received. If yes, please let me know whether Dr. B K Rai has ever been asked any explanation/clarification. Please provide me certified copies of all the such explanation/clarification letters communicated to Dr. B K Rai.

4) Please let me know the mechanism which was followed to ascertain that those threatening letters were actually written by Dr. B K Rai.

5) If it has not yet been ascertained that those threatening letters were written by Dr. B K Rai, please let me know the person who is falsely accusing Dr. B K Rai for having written those letters in the RTI reply of RTI Application (Ref: IITGW/R/E/20/00007).

6) Please let me know the name and designation of the official who decided not to provide me video recording under my RTI application (Ref: IITGW/R/E/20/00007) mentioning clause 8(1)(g).

7) Please let me know whether the director of IIT Guwahati instructed JR(Admin) to write the reply and deny the video recording. If yes, please provide the certified copy of the communication made by the director to the JR(Admin) in this regard.

8) Please let me know the name of employees who reported the matter of receiving threatening letters to JR(Admin). Please also provide certified copies of those communication.

9) Please provide certified copies of all the communication to JR(Admin) related to threatening letters allegedly written by Dr. B K Rai.
