4) Please let me know the total financial aid provided by the IIT Guwahati institute fund since filing the complaint case by Prof. Uday Shankar Dixit against Dr. Brijesh Kumar Rai till the disposal of the case. Please provide break up of the expenditure and also provide me a documentary proof for the same.
