Through this letter, interim registrar informed me that the proceeding of selection committee which selected me was scrutinized by an external audit and they found that I was paid more initial salary. A recovery has been proposed. Since I am unemployed and facing hardship, please</p>		

provide me the following information under RTI Act 2005 within shortest possible time period considering that I need this information for my life and liberty.

1. Certified copy of the recommendations of the selection committee which selected me.
2. Certified copy of the approval of BoG on the recommendations of the selection committee which selected me.
3. Certified copy of the letter from the external audit about the initiation of the scrutiny.
4. Certified copy of the letter from external audit about their findings in the scrutiny.
5. Certified copy of the opinion of the legal cell on the findings in the scrutiny.
6. Certified copy of the opinion of the internal audit on the findings in the scrutiny.
7. Certified copy of the list of all the proceedings of selection committees which have been scrutinized by the external audit and also provide me the certified copy of the findings of the external audit for each proceeding.
8. Please provide the certified copy of those proceedings where promotion were given without the candidate fulfilling the required minimum number of years of post PhD experience and the certified copy of the findings of external committee on those proceedings.
9. Please provide the certified copy of those proceedings of those committees where selection to Higher Academic Grade (HAG) were made from back dates. Please also provide me the certified copy of the findings of the external audit for each proceeding.
10. Please provide me certified copy of the response of the Institute to the findings in the scrutiny of all selection committee proceedings.
11. Number of faculty members who are affected by the findings in the scrutiny.
12. Institutional mechanism constituted to find all similar cases not found by the external audit.
13. Details of how an excess of Rs. 2,02,820/- in my case is calculated.
14. Please also let me know whether I was made to sign any paper mentioning that there could be discrepancy in the offered salary and/or other terms and conditions at a later stage. If yes, please provide me certified copy of the same.
15. Please let me know the name of officials identified for offering extra salary to the employees and also let me

know the action taken/initiated against them as per the point 3(iii), page 2 of the Office Memorandum (F. No. 18/26/ 2011-Estt (Pay-I) dated 6th February, 2014) issued by Department of Personnel & Training, Ministry of Personnel, Public Grievances & Pension, Government of India.
