3) Since July 01, 2019 to till March 08, 2020, for each official outstation visit of Prof. T G Sitharam, please provide me information whether the travel was made on Air India flight or a private flight.

4) Please provide a certified copy of the BoG resolution which allowed Prof. T G Sitharam to fly by a non Air India flight. Please let me know the name of official who had proposed the agenda for the same to the BoG meeting.

5) Since July 01, 2019 till the resolution of BoG permitting the director to travel by a non Air India airline, please let me know those official outstation travels by Prof. T G Sitharam which were traveled by non Air India airlines.

6) Since July 01, 2019 to till March 08, 2020, for each official travel of Prof. T G Sitharam, please let me know whether he traveled in business class or in economy class.

7) Since July 01, 2019 to till March 08, 2020, for all the official outstation visits of Prof. T G Sitharam, please provide the total cost (which include air fare, local travel by taxi etc., hotel cost, food cost) incurred to IIT Guwahati.
