- 2) Please let me know whether number of vacancies for PhD admission was mentioned in the advertisement. If yes, please provide me the documentary proof for the same.
- 3) Please let me know whether specialization wise number of vacancies was mentioned in the advertisement. If yes, please provide me the documentary proof for the same.
- 4) Please provide me the information about the process which is followed to decide the number of vacancies for PhD admission.
- 5) Please let me know whether applicants were told in the advertisement about the weightage of written test and weightage of interview in the final selection. If yes, please provide me the documentary evidence for the same.
