I undertake that the Assistantship will NOT be paid for the period of leave availed in excess of the number of days specified therein in any of my academic years. Absence without obtaining prior sanction of leave will be considered as an act of indiscipline and shall entail reduction of Assistantship on a pro rata basis, besides any other action that may be decided by the Institute.
- I also agree to undertake to abide and be bound by all and each of the terms of the existing rules and conditions governing the award of the Institute Assistantship subject to the modifications, alterations, amendments and additions as may be made to them from time to time.
