

#### **Alumni in News**

Avneet Singh, our alumnus (B.Tech/2012) is a member of the LIGO Scientific Collaboration (LSC), a group of more than 1000 scientists from universities around the United States and in 14 other countries. In 2016, he co-authored the paper which establishes the detection of gravitational waves.

Feltso was cofounded by our alumnus Thota Santosh (M.Tech CSE/ 2013) in 2015 and has been selected among the Top 10 startups for incubation at Spark10 Accelerator.

AddoDoc now Babygogo, was cofounded by our alumni Sowrabh NRS and Satyadeep Karnati (B.Tech, Class of 2012) raises \$300K funding.

Indian tax filing platform ClearTax founded by Archit Gupta raised \$1.3 million in a seed round from 10 Silicon Valley investors, including big names like PayPal Co-founder Max Levchin, serial investors Scott and Cyan Banister, Dropbox Vice-President Ruchi Sanghvi and WhatsApp's Business Head Neeraj Arora.

Online fashion rental platform Blinge, founded by Pooja Dubey (B.Tech CSE/2013) gets funding from Anupam Mittal, Ankit Nagori (ex-CBO Flipkart, IITG Alumnus).

Peter Thiel's Founders Fund has entered India with first investment in ClearTax, founded by Archit Gupta.

Playment, cofounded by our alumnus Ajinkya Malasane (Class of 2013) has raised \$699k funding from SAIF Partners.

Eyeing an IPO, Druva raises \$51M for its data backup, recovery and discovery services. Druva is co-founded by our Alumnus Jaspreet Singh (class of 2004).

Bike rental startup Tazzo raises seed funding from DSG Consumer Partners. Tazzo Bikes, a tech-enabled motorbike rental startup cofounded by our alumni Priyam and Shivangi, Class of 2013 and 2014.

Playment, cofounded by our alumnus Ajinkya Malasane (Class of 2013) has been selected for Google Launchpad Accelerator programme.

Idul Ahmed, IITG Alumnus (B.Tech, 2010) is the topper of the Indian Engineering Services 2016.

Richa Singh (Co-Founder YourDOST, B.Des Class of 2008), featured in the Forbes 30 under 30 list this year!
