This is for information of all concerned that, online & offline applications are invited in the prescribed format for Merit-cum-Means (McM)/SC-ST Scholarship for the year 2022-23.

The online dashboard link for application is https://online.iitg.ac.in/mcm and the link will be available from 22nd Jun`2022 for online submission. The hardcopy of application form for continuing students can be downloaded from the Students` Affairs website (https://intranet.iitg.ac.in/sa/api/forms/60eec690d676b1f931f237d3)

The last date for submission of Application is as detailed below:

- (a) Online application on or before 10th September 2022.
- (b) Hard copy dully filled in form along with all supporting documents in original to the Students` Affairs section 23rd September`2022 (for 2nd to 4th year student).

Salient features of the Scholarship:

- 1. This scheme is for students of BTech, BDes, MSc, MA & Preparatory Classes only.
- 2. The income of both the parents taken together shouldn't exceed Rs.6,00,000/- per annum.
- 3. All scholarships including, those for GEN & OBC students will be governed by their respective norms and durations, any student other than GEN & OBC can avail scholarship from the Institute for a maximum of 6 years.
- 4. Both Merit and Means will be given 100% weightage as per below for award of the Scholarships

Merit = 50% Means = 50%

The Merit-Cum-Means/SC/ST Scholarship consists of :

- (a) McM only for General /OBC category students: Tuition fee waiver for two semesters and a fixed stipend per month for two semesters (Aug-Nov & Jan –Apr totaling 8 months) of Rs.1000/- per month.
- (b) SC/ST only for SC/ST category students: Concession of tuition fee exemption will be admissible to all SC/ST students irrespective of their parents' income. For SC/ST students with parent's income not exceeding Rs.6,00,000/- per annum, following additional benefits will be admissible:
 - Free messing (Dues of only basic menu)
 - (ii) Exemption from Hostel Room rent and
 - (ii) A pocket allowance of Rs.250/- per month.

The above facilities are awarded for 4 (four) months per semester and for 2(two) semesters.
