TEMPORARY APPOINTMENT FOR THE POST OF JUNIOR TECHNICIAN (TRAINEE)

Online applications are invited for the post of Junior Technician (Trainee) in the Central Workshop at the Indian Institute of Technology Guwahati.

These are purely temporary post under contractual appointment. The contract period will be for 11 months and can be extended based on satisfactory performance and the requirements of the Institute.

1. **JUNIOR TECHNICIAN (TRAINEE)**: 06 posts (Turner: 02 Nos.; Machinist: 02 Nos.; Fitter: 01 No.; Welder: 01 No.)

Duration: Contractual Appointment for 11 Months (may be extended for another 2 terms of 11 months each based on satisfactory performance)

Remuneration: Consolidated stipend of Rs. 25,000 (Rupees twenty-five thousand only) per month will be paid during the contract period. Free hostel accommodation may be provided, subject to availability.

ELIGIBILITY CRITERIA

Educational Qualification:

- ITI Certificate in the trades of Turner/Machinist/Fitter/Welder from a NCVT/SCVT recognized Institute.
 - Minimum 60% marks or equivalent.
 - Candidates possessing higher qualifications such as Diploma/B.E./B.Tech are not eligible
2. The maximum age limit of the candidate should be 28 years on the last date of receipt of the application.

 4. Incomplete applications in any respect are liable to be rejected
