#### (i) Framing of Recruitment Rule of Senior Medical Officer (SMO)-

It was apprised to the Board that Dr. Mala Borthakur, CMO (SAG) retired voluntarily w.e.f. 31.07.2022. Dr. Mala Borthakur joined this Institute as Senior Medical Officer (SMO) on 10.11.1999 and was subsequently promoted to the post of CMO on 29.10.2008, CMO (NFSG) on 29.10.2012 and CMO (SAG) on 29.10.2015. So, after voluntary retirement of Dr. Borthakur, Senior Medical Officer (SMO) post has become vacant. As there was no Recruitment Rules for the post of SMO, a Committee was constituted with the following members to frame the recruitment rule for the post of SMO.

a. <u>Revision of Recruitment Rule (RR) of Senior Security Officer (SSO)</u>: In the 108<sup>th</sup> meeting of BOG held on 25.10.2021 the approved revised Recruitment Rule for the post of Senior Security Officer (SSO) was ratified. The Recruitment Rule of SSO was revised by converting the post of SSO into a tenure-based post of 5 years thereby changing the method of recruitment of the existing rule of SSO as 'Direct Recruitment (with provision of deputation) for a tenure of 5 years. Subsequently the post was advertised vide Advt. No IITG/R/07/2021 dated 14.12.2021 as per criteria approved and ratified in the 108<sup>th</sup> meeting of BOG held on 25.10. 2021. However, the selected candidate did not join the post as the post was tenure based and further the candidate requested to appoint him on regular basis instead of 5 years tenure. The waiting list candidate who then got the offer of appointment also did not join the post. Considering the importance of SSO post in the Institute like IITG which was lying vacant since August 2020, a committee was constituted with the following members to relook into the matter.

The Committee was apprised that the Recruitment Rule for the posts of Assistant Executive Engineer and Junior Engineer was approved in the 111<sup>th</sup> BOG, held on 17.06.2022.

The Committee after going through the existing Recruitment Rule of Assistant Executive Engineer and Junior Engineer, observed that in the existing Recruitment Rule, it is mentioned that the essential qualification in the case of promotion is applicable, which is not relevant to the promotion. So, Recruitment Rule of Assistant Executive Engineer (AEE) has been amended and given at <u>Annexure-17</u> (NOT ENCLOSED AS ALREADY UPLOADED).

In regards to the post of Junior Engineer, the BOG in its 111<sup>th</sup> meeting has approved revision of Recruitment Rule as below:"B Tech/BE with 2 years' experience or Diploma in Engineering with 3 years' experience

The present committee recommended revision /amendment of the Recruitment Rule of the post of Junior Engineer which is given at <u>Annexure-18</u> (NOT ENCLOSED AS ALREADY UPLOADED).

It was informed further that an honorary title is being conferred in recognition to the academic activities of a faculty member in different positions. Generally, the nomenclature used in the already approved policy document is "Honorary Faculty" for which it becomes extremely difficult for nominating a person for a particular position. In order to reflect the Institute's noble intentions to get associated with such eminent experts, it is proposed to modify the title from "Honorary Faculty" to "Honorary faculty (Assistant Professor / Associate Professor / Professor)".

#### <u>ltem No. 11</u>

To consider and approve the proposal to revise/modify the age limit criteria of the policy document for appointment of Honorary/Adjunct/Visiting Faculty and Professor of Practice at IIT Guwahati

The Board was apprised that a Policy Document for appointment of Honorary/ Adjunct/Visiting Foreign Faculty and Professor of Practice at IIT Guwahati was approved in the 102<sup>nd</sup> meeting of BOG vide resolution R102BOG/10/2020. In the said document the age limit criteria for all positions of Honorary/Adjunct/Visiting Faculty Professor of Practice is given as –"All positions end when the faculty member turns 70 years of age"

However, it has been observed most of the faculty members who have been offered honorary positions in the Institute are distinguished persons in their respective field. Most of them have superannuated but are still very actively associated with academics and research. In order to accommodate them, it is proposed to revise/modify the age limit criteria for all visiting and honorary positions as below:

The Board was requested to approve the aforementioned proposal.

The Board deliberated on the matter and **OPINED** to limit the extension till 70 years. In extraordinary cases the Director may be authorized to take a decision on case to case basis based on the merit of the case

The Board discussed and resolved as below:

**RESOLVED** to maintain the status quo of age limit for all positions of Honorary/Adjunct/Visiting Faculty Professor of Practice as given in the Policy document (i.e. up to 70 years).

Further **AUTHORIZE** the Director to take decisions on extension of term in case of Faculty with extraordinary profile on case to case basis for all positions of Honorary/Adjunct/Visiting Faculty Professor of Practice.

#### Item No. 12

#### To consider and approve the proposed post-retirement benefits to be offered to the retired/ superannuated employees

The Board was apprised that a proposal has been received from the Alumni & External Relation section of the Institute to offer the following post-retirement benefits to the retired/

superannuated employees as a token of gratitude and acknowledgement for the services rendered during the service period,

#### 1) Issue of Identity Cards:

Retired employee may be issued Identity cards providing details such as last post held before retirement, period of service rendered etc., which the retired employee can carry for identification as and when needed. The card may also include on the reverse the retired employee's Blood Group, his present residential address and telephone number.

#### 2) Access to email facilities:

Superannuated Professors may be granted continued access to their allotted IITG email accounts throughout their life.

#### 3) Honorary Faculty/Professor position to superannuated faculty members:

Honorary Faculty/professor position may be offered to retired faculty/professor, provided the faculty member has rendered meritorious services holding a reputation for integrity.

#### 4) Access to Institute's library resources:

Retired employees can be given membership after superannuation from the Institute to access digital library resources including e-books, journals, and databases.

#### 5) Guest house accommodation on subsidized rates:

Institute can offer Guest house accommodation to retired employees at semi – official rate primarily for the convenience who are coming to the campus for some academic or official work at IIT Guwahati, subject to the availability of rooms in the Guest house.

#### 6) Medical benefits scheme:

Some kind of health insurance benefits scheme (as per Gol norms) may be implemented for the superannuated employees and their spouses.

The Board was requested to approve the above mentioned proposed post-retirement benefits to be offered to the retired/ superannuated employees.

The Board deliberated on the matter and commented that regular recurring expenses to be avoided or excluded. So, the Board advised the Institute to exclude the proposal at SI 3 and 6 above. The Board discussed in detail and resolved as below:

#### Resolution No: R\_112 BOG/12/2022

**RESOLVED** to **APPROVE** the Proposal as below:

#### 1) Issue of Identity Cards:

Retired employee may be issued Identity cards providing details such as last post held before retirement, period of service rendered etc., which the retired employee can carry for identification as and when needed. The card may also include on the reverse the retired employee's Blood Group, his present residential address and telephone number.

#### 2) Access to email facilities:

Superannuated Professors may be granted continued access to their allotted IITG email accounts throughout their life.

#### 3) Access to Institute's library resources:

Retired employees can be given membership after superannuation from the Institute to access digital library resources including e-books, journals, and databases.

#### 4) Guest house accommodation on subsidized rates:

Institute can offer Guest house accommodation to retired employees at semi – official rate primarily for the convenience who are coming to the campus for some academic or official work at IIT Guwahati, subject to the availability of rooms in the Guest house.

The Board has not agreed to the proposal of Honorary Faculty /professor position to the superannuated faculty members and also extension of Medical benefit scheme to them, However it is up to Ministry of Education to consider any such medical benefit scheme to the superannuated employees as a policy matter applicable to all IITs as pending before Technical coordination division of the Ministry of Education & Ministry of Finance (under item No 53.9 of the 54<sup>th</sup> meeting of the Council of IITs) other than the existing Medical Facilities as extended to the IIT Guwahati which will continue till a decision is taken by MoE.

The meeting ended with a vote of thanks to the Chair and other members who attended the meeting.
