Due to an inadvertent omission, the **educational qualification for candidates from the Civil Engineering discipline** was not included in the aforesaid advertisement for the post of Assistant Executive Engineer (AEE).

Therefore, this addendum is published to add the civil engineering discipline in the educational qualification for the post of Assistant Executive Engineer.

Accordingly, the revised Educational and Other Qualifications for the post of Assistant Executive Engineer (AEE) is

- 1) Bachelor's Degree in **Civil Engineering** with at least 6 years working experience in design & estimation/supervision of construction of roads & multistoried buildings / maintenance of water supply and sewage system. **OR**
- (2) Bachelor's Degree in **Electrical Engineering** with at least 6 years working experience in supervision/design/estimation/ maintenance of electrical installations, sub stations, HT and LT distribution systems, internal electrification of buildings. **OR**
- (3) Bachelor's Degree in **Mechanical Engineering** with at least 6 years working experience in supervision/design/estimation/ maintenance of air conditioning system of 3000TR water cooled/air cooled chilled water based and 1800 HP VRV AC.

The last date for submission of online applications, originally scheduled as **21.10.2025**, is now **extended to 10.11.2025** for both the post of Assistant Executive Engineer (AEE) and Junior Translator.

All other terms and conditions of the advertisement no. IITG/R/11/2025 dated 01.09.2025 will remain unchanged.

Age Limit: Upto 30 years (No upper age limit for regular employees of IIT Guwahati).

Educational & Other Qualification:

Basic Qualification

(i) Master's Degree from a recognised University in Hindi with English as a compulsory or elective subject or as the medium of examination at the Degree level.

OR

(ii) Master's Degree from a recognised University in English with Hindi as a compulsory or elective subject or as the medium of examination at the Degree level.

Additional Qualification

Recognised Degree, Diploma or Certificate Course in translation from English to Hindi and vice versa and minimum two years' experience of translation work from English to Hindi and vice versa in Central Government or State Government Offices, including Government of India Undertaking

GENERAL TERMS & CONDITIONS

1.	For Assistant Executive Engineer: Applicants will have to make the payment of application fees through the online mode as under: ₹1000/- (for General/ OBC-NCL candidates). For Junior Translator: Applicants will have to make the payment of application fees through the online mode as under: ₹500/- (for General/ OBC-NCL candidates). SC/ST candidates, Women applicants and PWBD applicants are exempted from payment of application fee.
2.	Applicants should fill in the online application form provided in the link below: https://online.iitg.ac.in/recruitment. No physical copy of application / document is required to be sent. The link will be activated on 20.09.2025 Last date of receipt of online application: 21.10.2025.
3.	Relaxation of age for SC/ST/OBC/PWBD/Ex-Serviceman will be as per GOI rules. The SC/ST/ OBC candidates who apply against unreserved (UR) post will not be eligible for age relaxation.
4.	Reserved category applicants shall be required to upload the latest Caste certificate issued by the Competent Authority as per Govt. of India directives issued from time to time. Applicants belonging to OBC(NCL)/ EWS category will have to upload latest OBC(NCL)/ EWS certificate from Competent Authority in the prescribed format as per Govt. of India norms, which should not be more than one year old (from closing date of application). Otherwise, such applicants will be considered as unreserved category applicants. Similarly, PWBD applicants shall be required to upload proof of disability mentioning the percentage of disability issued by the Competent Authority.
5.	The applicant will be responsible for the authenticity of submitted information/documents and photograph. It is the responsibility of the applicant to assess his/her own eligibility to the post in accordance to the advertisement, if it is detected at any time in future, during the process of selection or even after appointment that the applicant was not eligible as per the prescribed Recruitment Rule of the Institute which could not be detected at the time of selection for whatsoever reason, his/her candidature/appointment shall be liable to be cancelled/terminated immediately.
6.	Mere fulfilling the conditions does not guarantee that the applicant will be shortlisted for the next phase of selection process. 9.	Persons already in regular service in Govt./ PSU must upload the NOC along with the application form. If any candidate is unable to upload NOC, they must give an UNDERTAKING in the format attached herewith, otherwise their candidature will be rejected.
10.	Incomplete applications / partially filled application forms/ applications without supporting documents will summarily be rejected.

11.	Amendments/Changes, if any, in the advertisement will be published only on the Institute's Website (www.iitg.ac.in).
12.	Selection will be made on the basis of the performance in the interview/Written examination / Skill Test (as applicable for the post) to be held by the Institute.
