AD/120/MHRD/00/Vol.21/09 dated 1- 1-2019) along with all its enclosures through which IIT Guwahati has furnished its comments.</p> <p>2) Please let me know whether it is true that the Standing Committee, formed to look into the appeals/representations relating to IITs, is supposed to give its report within 30 days.</p> <p>3) Please let me know whether the Standing Committee, formed to look into the appeals/representations relating to IITs, has submitted its report about the matter given to them vide letter (FiIe No.6-13/2018- TS-I) within 30 days.</p> <p>4) Please provide me a copy of the inquiry report/recommendation submitted by the Standing Committee about the matter communicated to them vide letter (FiIe No.6-13/2018- TS-I).</p> <p>5) Please let me know whether it is true that Standing Committee, formed to look into the appeals/representations relating to IITs, is supposed to contact the complainant as per the terms of reference of the committee.</p> <p>6) Please let me know whether Standing Committee, formed to look into the appeals/representations relating to IITs, has ever contacted IIT Guwahati authorities and/or Dr. Brijesh Kumar Rai. If yes, please provide all the letters/orders communicated between Standing Committee and IIT Guwahati and also all the letters/orders communicated between Standing Committee and Dr.</p>
