Dear Prof. Biswas,

I am writing this mail to bring to your notice a serious issue. I have already reported this to my department, dean of academic affairs and deputy director. In this sense, I have gone through proper channel and I have done my duty. It is the duty of all of us to bring to the notice to

higher authorities if we see any wrong doing. Please refer to questions and their responses of my RTI application (attached with this mail). It appears that there was a conspiracy to facilitate a non-deserving student to get MTech degree. Prima facie, the role a faculty from EEE department is highly questionable in this case. Indeed, academic dishonesty in an Institute like IIT is unacceptable. It is also worth noting that the Senate was misguided as the entire case has never been presented to the Senate. In this sense, I believe, you have never been told the whole story which should have been the case for you are the Senate Chairman.

With this mail, I request you to initiate a fair and impartial inquiry of the whole matter. I have done my part in trying to bring transparency in the system but my efforts will be wasted if no action is taken.

I sincerely hope that you will start inquiry. Of course, I reserve my right to file a PIL and/or to approach CVC. However, before doing that I may also write to BOG Chairman because I believe that an autonomous Institution like IIT should be able to resolve these kind of matters internally. It is only when all the internal options are exhausted, one should go to outside authorities to get justice.
