ORDER

WHEREAS 3 (three) numbers of disciplinary proceedings were initiated by the Institute against Dr. Brijesh Kumar Rai, Assistant Professor, Department of Electronics and Electrical Engineering (EEE), Indian Institute of Technology Guwahati, on grounds of misconduct viz., (i) an altercation with Dr. B Anand; (ii) Email complaint to ISRO by Dr. B. K. Rai without maintaining the channel of the official protocol and (iii) Complaint dated 16.01.2018 by the Head of Department (HOD), Department of EEE reporting dereliction of duty by Dr. B. K. Rai and information provided by Prof. Chitralekha Mahanta to the HoD, Department of EEE on 30.01.2018.

AND WHEREAS Charge sheets dated 23.11.2017, dated 26.12.2017, and dated 11.04.2018, were served on Dr. Brijesh Kumar Rai on 23.11.2017, 27.12.2017 and 11.04.2018 respectively. Dr. Brijesh Kumar replied to the charge sheets on 19.12.2017, 23.01.2018 and 03.05.2018 respectively;

AND WHEHREAS Departmental inquiries were conducted in the aforesaid disciplinary proceedings, culminating in inquiry reports dated 22.02.2018, 08.06.2018 and 29.04.2019, submitted by the respective inquiring authorities holding that most of the charges framed against Dr. Brijesh Kumar Rai had been proved;

AND WHEREAS the Board of Governors afforded an opportunity of personal hearing to Dr. Brijesh Kumar Rai on 31.10.2019. However he did not appear before the Board on 31.10.2019. The board continued the discussion on these three cases and also decided to issue two charge sheets in case of ISRO matter and dereliction of duty (second show cause for imposition of penalties under (iv) to (vii) of statutes of 15(9)) along with inquiry reports. Since Dr. Rai requested through e-mail for a personal hearing and the board decided to give Dr. Brijesh Kumar Rai another personal hearing before the board;

AND WHEREAS the Board of Governors considered the entire matter in a special Board meeting on 14.11.2019 and Dr. Brijesh Kumar Rai appeared before the Board and gave his responses;

AND WHEREAS, the Board of Governors of the Institute, as the Disciplinary Authority of Dr. Brijesh Kumar Rai considered the inquiry reports at great length and accepted the same after considering the representations of Dr. Brijesh Kumar Rai dated

12.04.2018 against second show cause notice dated 03.04.2018 (with regard to altercation with Dr. Anand), 13.08.2018 (and again second show cause on 01.11.2019 and reply on 11.11.2019 with regard to ISRO matter) against second show cause notice dated 24.07.2018 and 11.11.2019 against second show cause notice dated 01.11.2019 (with regard to dereliction of duty), at the board meeting held on 14.11.2019;

AND WHEREAS the Board of Governors in its meeting on 14.11.2019 decided to accept the three inquiry reports after considering Dr. Brijesh Kumar Rai's submissions, while concluding that each of the three cases were independently serious enough to merit the imposition of a penalty of dismissal from service (which would be a disqualification for future employment); However, at this meeting, the Board of Governors reconsidered the quantum of penalty and decided to impose the penalty of compulsory retirement on Dr. BK Rai, instead of the proposed penalty of dismissal from service;

AND WHEREAS, the Board of Governors at its meeting held on 26.12.2019 confirmed and approved the minutes of the meeting held on 14.11.2019 and directed that the penalty of compulsory retirement be finally imposed on Dr. Brijesh Kumar Rai with immediate effect and necessary orders be issued accordingly.

NOW THEREFORE, in compliance with the above directions passed by the Board of Governors, the the major penalty of Compulsory Retirement is hereby imposed on Dr. Brijesh Kumar Rai, Assistant Professor, Department of Electronics and Electrical Engineering, Indian Institute of Technology Guwahati with immediate effect.
