Dear Sir,

I am writing this letter to register a complaint about a case of corruption at IIT Guwahati. I was informed by some people of IIT Guwahati regarding two employees who have got permanent jobs at IIT Guwahati by using fake degrees. They also told me that the matter is known to the administration of IIT Guwahati and there is a nexus behind these kinds of employment at IIT Guwahati. To confirm, I got filed an RTI application and through its reply it is

confirmed that Mr. RajibDey has got employment at IIT Guwahati by showing B.P.Ed. degree from one BhartiyaShikshaParishad, Lucknow, UP and Mr. Roman Dutta has obtained a permanent position by showing M.P.Ed. degree also from BhartiyaShikshaParishad, Lucknow, UP. However, University Grant Commission has declared that any degree from BhartiyaShikshaParishad, Lucknow, UP is not recognized. Please see Annexure -1 for the same. It is pertinent to note that both Mr. RajibDey and Mr. Roman Dutta are working at IIT Guwahati for several years while they obtained their job using fake degree certificates. Employment of both at IIT Guwahati has caused loss of crores of rupees to exchequer.

This is a very serious matter. IIT Guwahati is not just any other Institute but an Institute of National Importance. It is shocking that in an Institute of National Importance as well, people are getting employment using fake degrees. I am an activist and working against corruption in Government Organizations in India. I consider it my duty to report this kind of matter to authorities concerned and that is the reason behind registering this complaint. I hope authorities will take a prompt action on my complaint.
