j. **Appointment from waiting list in respect of Jr. Technician , Computer and Communication Centre (CCC)**

Mr. Pranab Jyoti Boro has been selected for the post of Jr. Technician, Computer and Communication Centre (CCC) against Advertisement No IITG/R/10/2015 dated 02.11.2015 under UR category. This has been reported in the 90<sup>th</sup> BOG meeting held on 16.09.2017 vide resolution 90BOG/21(g)/2017.

However, Mr. Boro was also selected for the post of JTS in the Mathematics Department of the Institute and vide letter dated 06.09.2017 he informed the Competent Authority of the Institute about his unwillingness to join the post of Jr. Technician as he had already joined the Institute as JTS.
