(Land loser category)

Applications are invited from eligible candidates who have passed HSLC or equivalent examination under land loser category whose land was acquired for establishment of IIT Guwahati, for filling up of **10 Nos.** Junior Attendant post on purely temporary basis on consolidated pay of ₹12,000/- only per month with no other benefits.

Prescribed application forms may be collected from the office of the Administration Section, IIT Guwahati, Guwahati – 781 039. Applications completed in all respects along with enclosures and clearly mentioning the above Notification No. should reach Administration Section, IIT Guwahati, , Guwahati – 781 039 on or before **07.10.2016**. Incomplete Application forms or the applications not accompanied by the required documents will be rejected and no correspondence on the same shall be entertained.

Important Instructions:

1. Candidates should ensure that all documents as mentioned in the Application Forms are attached with the application as incomplete Application forms or the applications not accompanied by the required documents is liable to be rejected.
2. Land losers whose land has been acquired for establishment of IIT Guwahati (Self/Son/Daughter/Grandson/Grand-daughter) are eligible. However, IITG reserves the right to offer appointment only to one candidate from a land loser family based on the performance in the selection process.
3. To verify the actual descendants, the applicant must produce a family tree depicting his/her relationship with the land loser alongwith an affidavit (format for both will be given alongwith application form).
4. Candidates must possess the minimum educational qualification of class 10th standard pass.
5. Age limit should be between 18 years to 30 years as on last date for submission of application. Relaxation of age for SC/ ST/ OBC/PwD candidates will be as per Govt. of India rules.
6. Selection procedure shall be intimated by call letters to the shortlisted candidates.

7. The selected candidates shall have to appear in a medical test. Only medically fit candidates shall be considered for recruitment in IIT Guwahati.
8. A candidate trying to meet or bring pressure on members of the Selection Committee, officers or employees working in this Institute in respect of this selection process either by himself/ herself or through anybody else will be disqualified.
9. The selection /appointments will be made strictly in order of merit on the basis of performance of the candidates in the Selection process.
