Information Sought (जानकारी मांगी):	A. It is noted that Prof. S. N. Bora and Prof. Rifikul Alam, ex. Heads of Department of Mathematics, IIT Guwahati, have been served CALL FOR EXPLANATIONS by order of the Chairman Board of Governors of IIT Guwahati vide Office Order AD/LM/RS/429/16/Vol-II/5 and AD/LM/RS /429/16/Vol-II/6 dated 27.01.2020 respectively regarding the alleged corruption committed by Prof. S.N. Bora and Prof. Rifikul Alam.		

B. Further wide Office Order AD/LM/RS/429/16/17 dated 09.03.2020 an inquiry committee has been constituted to submit its report and recommendations within 90 days.

After going through the chronology of the above proceedings together with the guidelines for disciplinary proceedings of IIT Guwahati (attached), it seems that the concerned authority of IIT Guwahati should have issued SHOW-CAUSE NOTICES (having mention of specific charges of alleged corruption that might be framed through a brief preliminary inquiry committee) to Prof. S. N. Bora and Prof. Rifikul Alam.

2. Kindly provide a reason as to why SHOW-CAUSE NOTICES, in the above matter, have not been issued to Prof. S. N. Bora and Prof. Rifikul Alam by the concerned authority of IIT Guwahati. Please refer to the guidelines of the disciplinary proceedings of IIT Guwahati attached.

1. Kindly provide a reason as to why the concerned authority of IIT Guwahati, to examine the alleged corruption committed by Prof. S. N. Bora and Prof. Rifikul Alam, not placed Prof. S. N. Bora and Prof. Rifikul Alam under suspension, avoiding conflict of interest as Prof. S. N. Bora and Prof. Rifikul Alam are Ex. Heads of the Department of Mathematics of an IIT. Please refer to the guidelines of the disciplinary proceedings of IIT Guwahati attached.

Now in an unprecedented move, the institute has extended the tenure of the inquiry committee by twelve months without mention of any prevailing reason though the Office Order AD/LM/RS/429/16/39 dated 12.08.2020.

3. Kindly provide a reason as to why twelve months extension required.
